## PRODUCT DESCRIPTION

**Pro-Living® Bio-Solar Mount** is a load-supported solar mounting system for the mounting of PV modules without the need for roof penetration. The mounting system consists of a base plate and mounting frame and is supplied with screws and nuts for fastening as well as pre-assembled rail fixings.

## INSTALLATION

The longer side of the **Pro-Living® Bio-Solar Mount** frame is marked with a notch; it must be inserted into the base plate support which is also marked with a notch.

Insert the mounting frame as far as it will go into the support on the base plate.

Secure the mounting frame on both supports with the supplied shaft screws and cap nuts.
